2. The Petitioner- M/s. Pooja Enterprises, Bhimadevapour, Ganjam has filed the instant petition under Section 142 of the Electricity Act, 2003 for non-compliance of the order dated 02.07.2022 of the Learned Ombudsman-II passed in C.R. Case No. S-10 of 2021 arising out of order dated 27.09.2021 of the learned GRF, Berhampur passed in C.C. Case No. 170 of 2021.
3. The Representative of the Licensee-TPSODL submits that the order dated 02.07.2022 of the Learned Ombudsman-II passed in C.R. Case No. S-10 of 2021 arising out of order dated 27.09.2021 of the Learned GRF, Berhampur passed in C.C. Case No. 170 of 2021 has been complied with. Therefore, he prays before the Commission to close the present proceeding filed by the Petitioner under Section 142 of the Electricity Act, 2003.

The Learned Advocate appearing on behalf of the Petitioner submits that the Respondent-Licensee has not fully complied with the aforesaid order dated 27.09.2021 of the Learned GRF, Berhampur passed in C.C. Case No. 170 of 2021 and also the order dated 02.07.2022 passed by the Learned Ombudsman-II passed in C.R. Case No. S-10 of 2021.

5. Upon hearing the parties, the Commission directs the Learned Ombudsman-II to take up the matter in C.R. Case No. S-10 of 2021 and verify & pass order whether the same has been complied with in letter and spirit. Therefore, the Registry is directed to forward the Petition along with all the relevant documents to the Learned Ombudsman-II, Bhubaneswar.
6. The parties are directed to appear before the Learned Ombudsman-II on 28.05.2025 at 11.00 AM for next course of action in the matter. The Learned Ombudsman-II shall transmit the copy of the order as aforesaid.
