This matter is taken up for hearing through hybrid arrangement.

- 2. Shri Rabin Kishore Behera, the Authorized Representative of the Petitioner- Sri Subash das and Shri Biswaranjan Dehury, S.D.O (Electrical), Choudwar, TPCODL -the Respondent do appear. The Memo of compliance report submitted by the Petitioner is taken on record.
- 3. The Petitioner had filed the present petition under Section 142 of the Electricity Act, 2003 seeking execution of the order dated 15.01.2025 of the Learned GRF, Cuttack passed in C.C. Case No.334 of 2024. The Learned GRF, Bhubaneswar while disposing of C.C. Case No.334 of 2024, has issued the following directions:
 - "1. The O.P. is directed to extend new power supply to the premises of the Complainant within the time limit as specified in Regulation-33 of OERC Supply Code, 2019
 - 2. The O.P.is directed to terminate the power supply agreement of the service connection A/c. No.80016847891 observing Regulation 49 and other applicable Regulations of OERC Supply Code,2019".
- 4. When the matter is taken up for hearing today, the S.D.O (Electrical), Choudwar, TPCODL submits for closure of the case on the ground that the direction of the learned GRF, Cuttack imparted in order dated 15.01.2025 has since been carried out. The power supply has been restored on 07.07.2025 to the premises of the Petitioner/ consumer. To that effect, a photocopy of the report dated 07.07.2025 of Distribution Engineer, TPCODL is annexed to the compliance affidavit. In course of the hearing, the Authorized Representative of the Petitioner participated in the hearing online. To the query of the Commission, he also admits that the premises of the Petitioner, referred to in the Petition, has since

been supplied with electricity and submits that the Petitioner is no longer interested to proceed with this case.

5. In view of the implementation of the order dated 15.01.2025 of the Learned GRF, Cuttack passed in C.C. Case No.334 of 2024, as admitted by the Authorized Representative of the Petitioner, the Commission finds nothing more to proceed further in this case. Consequently, the case is disposed of on full satisfaction of the order of the Learned GRF, Cuttack.
