ORDER

This matter has been taken up for hearing through hybrid arrangement.

- 2. The Petitioner- M/s. Binayak Enterprises has filed the instant petition under Section 142 of the Electricity Act, 2003 alleging non-compliance of the order dated 24.12.2024 of the learned GRF, Cuttack passed in C.C. Case No.307 of 2024 and also Order dated 03.03.2025 of the S.E.-cum-Dy. Electrical Inspector, Cuttack passed in Case No.01/2025.
- 3. During the hearing, the Learned Counsel of the Respondent-Licensee-TPCODL submitted that as per the aforesaid order dated 24.12.2024 of the learned GRF, Cuttack passed in C.C. Case No.307 of 2024 and also Order dated 03.03.2025 of the S.E.-cum-Dy. Electrical Inspector, Cuttack passed in Case No.01/2025, they have made the remunerative calculation and have served the same on the Petitioner to make payment for execution of the work.
- 4. The Authorized Representative appearing for the Petitioner submitted that the Respondent-Licensee has not made the remunerative calculation properly following the provisions of the Supply Code, 2019. Therefore, it is prayed before the Commission to remand the matter to

the Learned GRF, Cuttack to examine the remunerative calculation made by the Respondent-Licensee.

- 5. Upon hearing the parties, we remand the matter to the Learned GRF, Cuttack to examine whether the remunerative calculation made by the Respondent-Licensee is as per their order or not and dispose of the matter after hearing both the parties and submit the report to this Commission within one month.
- 6. The parties are directed to appear before the Learned GRF, Cuttack on 28.05.2025 for next course of action in this matter. The Registry is directed to forward this order along with the Petition and all the relevant documents to the Learned GRF, Cuttack.
- 7. With the above observations and directions, the case is disposed of.
