This matter is taken up for hearing through hybrid arrangement.

2. This is an application u/s 142 of the Electricity Act, 2003 wherein the Petitioner has sought implementation of the order dated 08.12.2023, passed by the Learned Ombudsman-II in C.R. Case No.42 of 2023 arising out of order dated 21.07.2023 of the Learned GRF, Balasore in C.C. No.174 of 2023, by the Respondent.
3. When the matter is taken up for hearing today, the Representative of the S.D.O (Electrical), Kuliana, Mayurbhanj submits for closure of the case on the ground that the direction of the Ombudsman-II in C.R. Case No.42 of 2023 has since been carried out. It is submitted that the disputed electricity bill of the Petitioner has already been revised from September, 2021 to August, 2023 after taking average consumption recorded in the new meter, which was installed on 11.09.2024, during the period from April, 2024 to September, 2024 as per OERC Distribution (Conditions of Supply), Code, 2019. It is further submitted that after revision, an amount of Rs.39819/- will be withdrawn and the same will be reflected in the bill for the month of July, 2025. In course of the hearing, the Authorized Representative of the Petitioner

participated in the hearing online. To the query of the Commission, he also admits that the order dated 08.12.2023, passed by the Learned Ombudsman-II in C.R. Case No.42 of 2023 arising out of order dated 21.07.2023 of the Learned GRF, Balasore in C.C. No.174 of 2023 has been complied by the Respondent-Licensee and submits that the Petitioner is no longer interested to proceed with this case.

4. In view of the above submission, the Commission finds that the order dated 08.12.2023, passed by the Learned Ombudsman-II in C.R. Case No.42 of 2023 has been implemented in letter and spirit. As such, the case is disposed of on full satisfaction of the order of the Learned Ombudsman-II, Bhubaneswar.
