In the matter of: Application under Section 142 of the Electricity Act, 2003 alleging non-compliance of order dated 24.09.2024 of the learned GRF, Dhenkanal passed in C.C.No.136 of 2024.

This matter is taken up for hearing through hybrid arrangement.

2. Shri Rabin Kishore Behera, the Authorized Representative of the Petitioner-Sri Ganesh Prasad Rout and Shri Satyakam Ghose, Lead Associate (Legal), along with Shri Goutam Jayprakash on behalf of the Respondent-Licensee, TPCODL do appear. The Memo of compliance report submitted by the Petitioner is taken on record.
3. The Petitioner has filed the instant petition under Section 142 of the Electricity Act, 2003 seeking execution of the order dated 24.09.2024 of the Learned GRF, Dhenkanal passed in C.C. Case No.136 of 2024. The Learned GRF, Dhenkanal while disposing of C.C. Case No.136 of 2024, has issued the following directions:

“The Opposite Party is directed to credit Rs.8091.22 towards bill revision amount as already finalized and the rebate of Rs. 606.35 availed under OTS should be debited as would be more beneficial to the petitioner”.

4. When the matter is taken up for hearing today, the Representative of the Respondent-Licensee, TPCODL submits for closure of the case on the ground that the direction of the learned GRF, Dhenkanal imparted in order dated order dated 24.09.2024 has since been carried out. The Petitioner-Consumer's bill has been revised as per the direction of the Learned GRF, Dhenkanal and the said revision statement is served on the Petitioner/ consumer. To that effect, a photocopy of the revised bill statement vide ANNEXURE-A attached to the affidavit dated 17.06.2025 of Respondent- TPCODL. In course of the hearing, the Authorized Representative of the Petitioner participated in the hearing

online. To the query of the Commission, he also admits that the Respondent-Licensee has complied with the order dated 24.09.2024 (Supra) and submits that the Petitioner is no longer interested to proceed with this case.

5. In view of the implementation of the order dated 24.09.2024 of the Learned GRF, Dhenkanal passed in C.C. Case No.136 of 2024, as admitted by the Authorized Representative of the Petitioner, the Commission finds nothing more to proceed further in this case. Consequently, the case is disposed of on full satisfaction of the order of the Learned GRF, Dhenkanal.
