# Wanting Information in OPTCL's ARR Filing, 2007-08

## **TECHNICAL:**

- 1. TRT-23: Information required under TRT-23 relating to expected revenue from charges (Ensuing Year) of OPTCL have not been furnished.
- 2. OPTCL has proposed transmission loss at 5.0 % for FY 2007-08 which and needs to be substantiated with supporting details. Detailed computation of month wise transmission loss (with import and export details) for FY 2005-06 and FY 2006-07(April-Nov,06) may be furnished. Further, the bulk supplier has projected a transmission loss level of 3.64% in para 1.3 of the ARR Application for the Central Sector Power. Justification for proposing such a high level of loss for CTU may be given particularly considering the fact that the Central Sector power mainly flows in 220 KV / 400 KV lines.
