2. Size of Pages: ¼ (Demi Size)
3. Quantity: 100 Copies
4. Cover Board: (i). Paper: 220 GSM Art with Multi Colour
(ii). Printing: Multi colour with lamination cover writing should be English only.
5. Inner Printing: (i). Multi color 20 pages maximum (100 GSM Art paper)
(ii). Bi-colour balance page.
6. Inner Paper: 90 GSM sewing with colour pasting.
7. Binding - Section sewing with cover Pasting.

The interested firms should send their quotations to the OSD (PAO), OERC, with sealed cover clearly mentioning in bid letter on the top of the envelope “**Quotation for Printing of Compendium of Tariff Orders for FY 2026-27**”. The quotation should include the total cost of printing and per-page (bi-colour) and multi-colour printing charges. The price should be exclusive of applicable taxes.
