In this regard, the following criteria are to be followed:

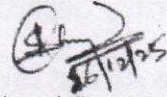
- A-1. Go-Ahead is given for execution of the mitigation projects as approved in the State Executive Committee in its meeting held on 02.12.2025.

3. The Delegation of Financial Power Rules, 1978 latest amended up to 04.03.2025 vide FDOM No. 7460/F dated 04.03.2025 & the Odisha Public Works Department (OPWD) Code are to be followed scrupulously.
4. Complete transparency of process is to be followed at all stages.

- B-1. On completion of the duly adapted tendering process, Work Orders are to be issued. After issue of Work Order, requisition of funds indicating schedule of requirement of funds on quarterly basis is to be submitted to SRC as per enclosed format.
2. The entire execution period should be divided into different quarters and anticipated expenditure on quarterly basis should be furnished.
3. On release of funds to the Department, the same is to be utilized within one month & Utilization Certificate thereof to be submitted.
4. After receipt of UC of funds already released during previous quarter, funds for the subsequent quarter will be released.

This approval is subject to further Guidelines of SDMF by Govt. of India on 16th Finance Commission recommendation.

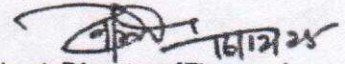

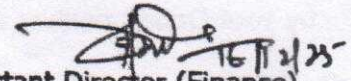
